

2025-2026 Graduate Student Application for Professional Development Scholarship &

Scholarships for professional development are made available through the Virginia Talent + Opportunity Partnership (V-TOP), a public-private partnership formed between the Virginia Chamber Foundation and the State Council of Higher Education for Virginia (SCHEV). Virginia TOP is tasked with creating greater connectivity between students, institutions of higher education and the employer community to expand paid and credit-bearing internship and other work-based learning opportunities (job shadowing, tours, mentorship, externships, apprenticeships, field experiences, etc.). Virginia TOP is organized through the Commonwealth Innovative Internship Fund and Program and administered by SCHEV.
